LSU will set prices and all tickets will be sold through LSU. Participating schools can buy tickets through LSU and then sell to their members. LSU will cover all costs. Profit share may be considered if money is made on the ticket sales. Schools will be given tables to sell their silent auction items and school memorabilia. Any schools wishing to participate in the raffle will need to have 10 prizes donated. All schools participating in the raffle will share evenly in the raffle money.

Mickey has stated that the boil will be tentatively scheduled for the 3rd Saturday in May to make scheduling easier for chapter members and vendors.

Prime Cut has entered a bid contingent on the price of the crawfish. Mickey will call sources in Louisiana for crawfish prices. Glenn Thibodeaux contacted Chapter about supplying crawfish.

Colors this year will be purple, green and gold to show solidarity of the schools with no school flying their colors.
